## FILM PLASTIC RECYCLING

- Plastic salt bags
- Plastic bird seed bags
- Plastic fertilizer bags
- Ground cover garden plastic
- Clear or black plastic sheet plastic
- Plastic mesh animal feed sacks
- Plastic grocery or retail sale bags
- Shrink wrap plastics
- Plastic must be clean, empty, and debris free.
- Container plastic, such as bottles, should be placed in appropriate dumpster, not in the tote.
- Totes are for film plastics only
  no containers, paper, or trash.







# At your farm:

## AG PLASTIC RECYCLING

### White and black:

- Bunker covers
- Silage bags

### White/green/brown

Bale wrap

#### Other

- Plastic sacks
- Plastic twine
- Bale mesh

# WHAT HAPPENS TO THE COLLECTED PLASTIC?

The collected plastic is sent to a processing facility where it is manufactured into interlocking plastic sidewalk tiles.



The Taylor County Recycling Authority is also investigating the possibility of sending the plastic waste to a biofuels facility that would convert the plastic into fuel.

#### A FEW PLASTIC FACTS

- Every year enough plastic film is produced in the U.S. to shrink wrap Texas.
- A car can drive about 1 mile on the amount of petroleum used to make 14 plastic bags.
- At least 12 million barrels of oil are used per year to make the 100 billion plastic shopping bags used by Americans.

# WHY SHOULDN'T I BURN MY WASTE PLASTIC?

### What's so bad about burning plastic?

It is unhealthy. Burning plastics releases toxic and potentially cancer causing chemicals into the air.

It pollutes. Toxins released into the air during burning can fall on our soils and in our water.

It is unsafe. Burning garbage or brush can lead to wildfires, property damage and sometimes loss of life. The smoke and ash can irritate eyes and lungs, which is especially bad for people with asthma or heart disease.

### It is illegal to burn any plastics in Wisconsin.

Under no circumstances should plastics, including film and ag plastics, be burned, even on your property.

"It is illegal to burn asphalt, garbage, metal, petroleum products, <u>plastics</u>, rubber and painted or treated wood. These materials release toxic pollutants into the air and are recognized as a significant health risk and public nuisance. Burning recyclable paper or cardboard is also prohibited."
