

## Town Board Meeting – Tuesday, May 14, 2013

- Town Board Meeting was called to order by Chairman Craig Bolz at 7:00 p.m.
- Reciting of the Pledge of Allegiance was conducted.
- Roll Call- Present were: Chairman Bolz, Supervisor Bill Grote, Supervisor Elvin Doberstein, Treasurer Holly Sromek, Clerk Mary Quante, and Grader Operator Steve Rogers.
- Chairman Bolz certified the meeting to be in compliance with the open/closed meetings law. Agenda was posted at the Grover Town Hall, Recycling Center and the corner of Winter Sports Road and State Hwy 64.
- Motion to approve the May 14, 2013 board meeting agenda was made by Doberstein, seconded by Grote, motion carried.
- Clerk Quante read the meeting minutes from April 16, 2013. Motion to approve the minutes was made by Doberstein, seconded by Grote, motion carried.
- Treasurer Sromek provided treasurers report for review. Sromek was thanked for a job well done.
- Approval of Expenses: Highway #1992 through #2003, motion made to approve highway expenses was made by Doberstein, seconded by Grote, motion carried. General #2130 through #2139, motion made to approve general expenses made by Doberstein, seconded by Grote, motion carried.
- Discussion on building permit fees. Bolz expressed concern regarding the \$40 Inspection Fee on the building permit applications. Removing the inspection fee may encourage more residents to build. Bolz made a motion to remove the \$40 Inspection Fee from the building permit application, seconded by Doberstein, motion carried.
- Reviewed submitted building permits by David Goessl and Combined Cabinetry . Motion to approve building permits made by Bolz, seconded by Grote, motion carried.
- Open Book date set Monday, June 3, 2013 6 p.m. to 8 p.m. and Board of Review date Thursday, June 6, 2013 6 p.m. to 8 p.m.
- Discussion on Grader Operator position. Rogers resignation date is June 1, 2013. The Board reviewed the job description. Motion made by Doberstein to post the grader operator position ad in the classified section in the local newspapers for the next three weeks (May 21, May 28<sup>th</sup>, and June 4<sup>th</sup>), seconded by Grote, motion carried.
- Discussion on opening roads for ATV use and possible ordinance. Don Liske President of the Taylor County ATV Club attended meeting to discuss options, suggestions, ideas, and costs. Motion made by Doberstein to form an ATV Committee consisting of residents of Grover, seconded by Grote, motion carried.
- Discuss road limit extensions. Bolz requested all weight limit signage be removed by Monday, May 20<sup>th</sup>, 2013.

- Discuss Community Clean-up Day and garbage disposal. It was suggested all garbage collected on this day be disposed of at the Town of Grover Recycling Center since it is gathered in the township limits. Motion made by Doberstein to approve garbage to be disposed of at the recycling center, seconded by Grote, motion carried.
- Future Agenda items: Dust Control, Liquor Licenses, Board to go into Closed Session to review grader operator job applications/resumes
- Motion to adjourn made by Bolz, seconded by Doberstein, motion carried. Meeting adjourned at 7:57p.m.
